Greetings from the Norwegian Ambassador to Estonia, H.E. Ms. Else Berit Eikeland

FROM BOARD TO MEMBERS

Since the new management board elections in December 2020, the board frequently met to discuss and develop new plans for NECC in 2021. One of their focuses was to hire a new, highly motivated General manager who could improve administrative processes with the implementation of new tools for document handling and storage. Someone who can support the board in executing the strategy for further development of the chamber and contribute with new ideas to increase NECC's value for you as a member.

NECC operating costs have been reduced by establishing a favorable long-term contract for our administrative service provider and tendering for a new service provider for accounting services. NECC kindly thanks Sektor Digital for working with the chamber on an improved agreement for web services.

In the year 2021, NECC also celebrates 100 years of diplomatic relations between Estonia and Norway, which is bringing many new exciting opportunities. The board in NECC set a goal to become more visible and contribute to sharing information about relevant events also from our partners. The chamber wished to spread information about public events for members, partners, and guests through its website and social media accounts. Events that can be participated by NECC members only will be shared by direct member emails or by invitation.



STRATEGY IN 2021

In 2021 the chamber wished to remain as active as possible while complying with the COVID restrictions. NECC planned to host an informal mingling for members and interested parties every first Thursday of the month in "Andre etasje," located in Tallinn Old town. A representative from the board and the General manager were attending, and the events were open to everyone interested.

NECC planned to continue to provide its members and partners events with relevant content and networking possibilities. The following events were planned to be executed in the best way possible, pending COVID restrictions at the event's time.

April.

Online event moderated by the chairman Joar Terjesen, with one of the new government ministers, followed by Q&A.

May

Annual General Meeting combined with a conference where the theme will be around Estonia's financial outlook for the future now that NECC is hopefully soon entering a post COVID era.

17th May celebration with the Royal Norwegian Embassy, Norwegian families in Estonia, friends of Norway, and other interested parties. This included traditional activities such as a marching band parade with songs and flags in Tallinn old town. After this part of the celebrations, there would be an open event at the Norwegian Ambassador residence for children and adults, including games, 'Pølse og is' (hotdogs & icecream), and of course some speeches.

June or August

Outdoor summer event in cooperation with partners and other chambers with fair competition and plenty of opportunities to mingle and network.

September or October

Large event in cooperation with the Royal Norwegian Embassy in the autumn like previous years. The tradition of Norwegian Business awards is currently being discussed to bring back in 2021.

November or December.

Norwegian Christmas dinner to gather one last time and finish the year on a high note before we all enter the holiday season.



NORWEGIAN CAPITAL PRESENCE IN ESTONIA

The shrinkage of Norway's direct investments in Estonia impacted different industries differently. WEBINAR

with Andres Sutt: "Future of Entrepreneurship in Estonia"

In May 2021, NECC invited its members to a webinar "Future of Entrepreneurship in Estonia" in cooperation with the Estonian Minister of Entrepreneurship and Information Technology, Andres Sutt.

Mr. Andres Sutt is the Estonian Minister of Entrepreneurship and Information Technology since 26 January 2021. He was elected to Riigikogu on March 3, 2019, as a member of the liberal Reform Party.

Mr. Sutt has over 25 years of international experience in central banking, bank restructuring, and crisis management. He has worked as the Deputy Governor of the Bank of Estonia, as the head of banking at the European Stability Mechanism, and as a senior advisor to the head of the European Financial Stability Facility. In addition, he has been the Estonian representative on the Executive Board of the IMF. He has also worked as the Chief Services Officer for Enefit, Estonia's largest energy utility enterprise.

Mr. Sutt serves as a board member of SOS Children Village Estonia, Estonian Maternity Hospitals Foundation, and the University of Tartu Foundation.

He has a master's degree in economics and finance (cum laude) from Tartu University, Estonia, and has studied management in INSEAD, France.

During the event, Mr. Sutt gave an overview of the key objectives and focus areas for the Minister of Entrepreneurship and Information Technology, did a Q&A with questions pre-collected from NECC members, and spoke about the debate of key challenges for Innovation and Foreign investments in Estonia.

This event was moderated by the NECC board member, Jaanus Stern, who is also an attorney at Leadell Pilv AS. Between the seminars, we introduced delicious Estonian food, whereas we divided the participants into groups, and they had to guess the ingredients of the dishes.




